- 2. The certificate shall be valid until invalidated by formal notice by the Local Authority Building Standards Scotland.
- 3. The design shown and the materials specified shall not be changed without reference to the Local Authority Building Standards Scotland responsible for certifying the system.
- 4. Where reference is made on a plan or specification document to any Code of Practice, British or European Standard or manufacturer's instruction it shall be construed as a reference to such publication in the form in which it is in force at the date of this certificate.
- 5. This certificate should not be regarded as a formal approval under the building warrant process prescribed by the Building (Scotland) Act 2003 enacted from 1 May 2005
- 6. This certificate covers the fit out of a generic building, which is not included within this assessment. The pending warrant applications will therefore be applied for based on a shell and subsequent fitout. This STAS approval therefore is only applicable to the fit-out application.
- 7. The building shell, associated site works, and drainage do not form part of the approval.
- 8. A simplified building energy model (SBEM) calculation will be required for the fit-out warrant application and does not form part of this STAS approval as it will be dependent on building location and aspect.
- 9. A statement of sustainability will be required for the fit-out warrant application and does not form part of this STAS approval.
- 10. An energy performance certificate will be required for the fit-out warrant application and does not form part of this STAS approval.
