SYSTEM: Robust Details – Scotland Section 5 Scheme  
To be used as an alternative to pre-completion sound testing to demonstrate compliance with the sound insulation requirements of Section 5 of the Building (Scotland) Regulations 2004 for new build attached dwellings.

### C Conditions of certification:

#### Validity and Scope

1. That the specifications and materials referred to have been assessed and approved in accordance with the Building (Scotland) Regulations 2004 and in accordance with the supporting guidance in the Domestic Technical Handbooks which came into force with effect from 1 October 2011.
2. That where reference is made on a plan or specification document to any Code of Practice, British or European Standard or manufacturer's instruction it shall be construed as a reference to such publication in the form in which it is in force at the date of this certificate.
3. That the details and the materials specified shall not be changed without first gaining approval so to do from the Scottish Association of Building Standards Managers [SABSM]. Failure to do so will invalidate the certificate.
4. That the certificate shall be valid until invalidated by formal notice by SABSM.
5. This certificate should not be regarded as a formal approval under the building warrant process prescribed by the Building (Scotland) Act 2003 enacted from 1 May 2005

#### Testing and Accreditation

6. That Robust Detail V-WM-19 Masonry Separating Wall comprising dense or lightweight aggregate blockwork with a minimum 100mm cavity and rendered both faces and lined with gypsum-based board on both faces and with MONARFLOOR<sup>(R)</sup> BRIDGESTOP<sup>(R)</sup> system shall be installed strictly in accordance with the manufacturer's instructions, in accordance with the certificate holder's instructions and fully in accordance with the accredited certification and supporting test reports held by Robust Details Ltd.
7. That the relevant person must provide sight/a copy of the Robust Detail Checklist as completed and signed by the Site Manager/Supervisor for the as built installation for each unit which is registered by RDL Ltd under their procedures, if requested to do so by the Verifier.

#### Site Specific Assessments

8. That all site specific materials and constructions not within the scope of this certificate but which otherwise contribute to compliance with Mandatory Standard 5.1 as well as other related Sections of the Technical Handbooks shall be designed in accordance with all relevant Codes of Practice, British or European Standards and installed strictly in accordance with the manufacturer's instructions.

### D Limitations of use:


1. That each site specific building warrant application proposing the use of the Robust Detail V-WM-19 elements shall confirm full compliance with Mandatory Standard 5.1 as well as other related Sections of the Technical Handbooks
2. That the Verifier receives confirmation that all plots subject to this System Type Approval are registered by RDL via the submission of the appropriate RDL Purchase Statements to the Verifier before commencement of work.

**Note:** Failure to provide the appropriate RDL Purchase Statements and/or sight of the completed Robust Detail Checklist may result in the need to evidence compliance with Mandatory Standard 5.1 via pre-completion sound testing.
